Our company sources the agricultural products from the manufacturers by paying an advance payment or as per agreed terms and then these products are sold to our network of distributors. Owing to our presence in the market, we have built strong relationships with both the farmers as well as with the wholesaler/retailers’ community.

In contract manufacturing, our company leases an agricultural land on lease and cultivate Cucumber, Onion and Castor for meeting the demand in the market. This gives the company control over the entire process and getting the agricultural produces at better rates as compared to the market. A part of the yield is shared with the farmers working on contractual basis on the leased land, which further helps the local farmers’ community. Our company is engaged in the business of trading of agricultural commodities such as wheat, rice, maize, vegetables including capsicum, tomato, Green Chilly, Onion, Potato etc, Fruits including Apple, Red Dragon, Sweet Lime, Pomogranate and other agricultural products

8. INTERNAL RISK FACTORS

The below mentioned risks are the top ten risk factors as per the Letter of Offer:

1. The Registered Office and Godown of our Company are located/ carried on land parcels that are not owned by us and are held by us on a leasehold/ rental basis. In the event we lose or are unable to renew such leasehold rights, our business, results of operations, financial condition and cash flows may be adversely affected.
2. Our insurance coverage does not adequately protect us against losses (including damages or loss caused to the Products), and successful claims against us that exceed our insurance coverage could harm our results of operations and diminish our financial position.
3. We do not maintain long-term contracts with our third-party suppliers, and our business may be adversely affected by a shortfall in supply, or increase in price of materials.
4. Our Company has not entered into any long-term contracts with our distributors/customers and we typically operate on the basis of orders received on hand. Inability to maintain regular order flow would adversely impact our revenues and profitability.
5. Spright Agro Limited's agricultural commodity trading business is subject to several risks associated with its supply chain. The company sources various agricultural commodities such as wheat, rice, maize, vegetables including capsicum, tomato, Green Chilly, Onion, Potato etc, Fruits including Apple, Red Dragon, Sweet Lime, Pomogranate and other agricultural products. The company is also engaged in contract manufacturing for agricultural products such as Potato, Cucumber and Onion and other agricultural products from different regions, and any disruption in the supply chain could have a significant impact on its operations and financial performance.
6. The agricultural commodity trading business is highly seasonal and such seasonality may affect our operating results and cash flow of our Company.
7. We have only three warehouse and we do not own any cold storage facility to store our products, instead we rely on the cold storage facilities available with the supplier. Damage to seeds and agricultural produce due to the unavailability of adequate warehouses at the right time may adversely affect our business, financial condition and results of operations.
8. Major portion of our revenue is derived from a limited number of customers. Any failure to retain one or more of our customers or any disruption of sale of our product will have an adverse effect on our financial performance and results of operations.

9. We are heavily dependent on certain suppliers and customers for procurement and sale of our traded goods. Any disruption in supply or offtake from such entities may affect our business operations.
10. Our business operations are majorly concentrated in certain geographical regions and any adverse developments affecting our operations in these regions could have a significant impact on our revenue and results of operations.
